3. We note that there has been considerable correspondence from you concerning the very modest demand for contribution towards the cost of the electricity. The cost of this firm becoming involved in the dispute would, frankly, be wholly disproportionate to the amount that is in issue. **We expect that this matter should be resolved on a sensible basis between you and Martin Russell Jones**, and at minimal further cost.

4. We will ask the managing agents to clarify when it is anticipated that the year end service charge accounts would be prepared.

While we do not consider that it is appropriate that we should become involved in correspondence relating to each item of the service **charges, we have to say that we do not consider that you are entitled, under the terms of the Lease, to deduct £293.75 for the cost of Frank Morris Associates in providing advice to you concerning alleged defects to the premises.**

5. Noted.

6. We note your comments. You have not paid the standing charge in respect of electricity charges and **you are therefore in breach of your obligations under the terms of the Lease.**


7. We acknowledge receipt of £75.00 in respect of ground rent.

We further note that you have made no proposals in respect of the major works contribution. Our client will therefore take such action as it considers appropriate to recover that sum from you. If it becomes necessary for it to do so, our client will also refer to your substantial delays in making payments of service charges and other sums during the past several years. Your consistent failure to pay such sums is a matter that could be taken into account by the Court in considering the weight to be given to your complaints now.



We are writing further to our letter of 8 October 2002 and your telephone call in reply.

2. We have previously been notified that the directors of Steel Services Ltd are FMC Ltd, Tropic Isle Building, Wickhams Cay, Road Town, Tortola, British Virgin Islands.
3. 25-26 Hampstead High Street, NW3 1QA is the address for service of Steel Services Ltd in England and is their solicitors Cawderly Kaye Fireman & Taylor office address.

Please confirm if this is correct. If this is the case, then in order for you to fully meet your obligations under section 1 of the Landlord and Tenant Act 1985, please can you confirm in writing the address of Steel Services Ltd in the British Virgin Islands. Please provide this information within 21 days of the date of this letter to avoid the possibility of prosecution.
