REPLY TO YOUR 11 JANUARY 2010 LETTER

Thank you for your letter of 11 January 2010 (posted second class on the 12<sup>th</sup>, of which I took delivery on 17 January), in which you acknowledge receipt of my 2 January 2010 Subject Access Request, and returned my cheque.

As requested, I enclose:

- Another NatWest cheque, #1501, for £10.00 - this time made payable to "Her Majesty's Paymaster General"<sup>1</sup>
- As to "proof of identity" which can be "a copy of a recent utility bill" – I enclose a copy of my 'Council Tax 2009/2010' demand<sup>2</sup>

In relation to your question:

"Due to the size of the Department, it is not possible to conduct a search of each MoJ location. I would be grateful if you could let me know which parts of the Department you wish me to conduct the searches e.g. such as a specific office of the Tribunals Service or court in Her Majesty's Court Service"

I refer you to the following in my 2 January 2010 Subject Access Request:

1. **The front page** and following page of my document which contains a list of content, headed "The sections and page location are" – listing all the sections in the document with their corresponding page number. They include:
  - Section 4.2, headed "Information request from the Leasehold Valuation Tribunal – for 2002-03" – "page 11"
  - Section 5.2, headed "Information request from West London County Court – for 2002-04" – "page 22"
  - Section 6.2, headed "Information request from Wandsworth County Court – for 2004" – "page 28"
  - Section 7.2, headed "Information request from HMCS 'Customer Service' – for 2004" – "page 31"

- Section 9.2, headed *“Information request from West London County Court – for 2007-08” – “page 62”*
- Section 10.2, headed *“Information request from HMCS ‘Customer Service’ – for 2007-08” – “page 77”*
- Section 11.3, headed *“Information Request from Supreme Court Costs Office – for 30 January 2009” – “page 85”*

Each of the above sections contains very specific questions, **addressed to named individuals**.

2. I also point out to you that:

- **On the front page** of my 2 January 2010 Subject Access Request, under 1 *“Introduction”*, I state *“This Subject Request relates to events with”* – and list, as bullet points: *“The London Leasehold Valuation Tribunal in 2002-03...; West London County Court in 2002-04 and in 2007-08; Wandsworth County Court in 2004; Supreme Court Costs Office on 30 January 2009; HMCS Customer complaints departments in 2004, and in 2007-08”*
- **On the second page** of my document, under section 2, headed *“Parties and abbreviations”*, sub-section 2.1, headed *“Courts and tribunal”* – which - for each location – listed as:
  - *“London Leasehold Valuation Tribunal”*
  - *“West London County Court”*
  - *“Wandsworth County Court”*
  - *“HMCS ‘Customer Service’”*

I list the **individuals concerned**, specifying, as relevant, the year, and, in the case of *“HMCS ‘Customer Service’*, also give the office of the individual.

Considering the extremely obvious and absolute clarity of the locations and individuals concerned – as evidenced by the above - I find it extraordinary that ‘you’ asked me this question.
