Please, consider the enclosed letter as having been addressed to you, rather than to Mr Gallagher.

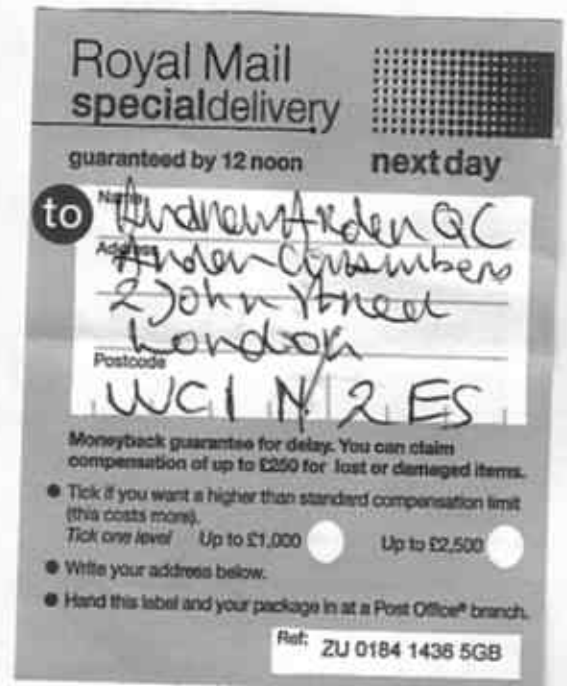
I have since replied to Piper Smith & Basham letter of 18 December 2003. I enclose both, their letter ³ and my reply ⁴
