Dear Mrs Manzoor,

Failure by the Bar Council to deal with my complaint against Mr Stanley Gallagher, Arden Chambers, London WC1N 2ES

I am escalating my complaint to your Office as I consider that the Bar Council has either ignored or dismissed all the substantive points in my complaint against Mr Stan Gallagher, Arden Chambers. Mr Gallagher was employed to advise me in relation to an offer received from the landlord for my block, dated 21 October 2003.

This complaint is connected with the complaint I have already referred to your Office against (1) Mr Richard Twyman and Ms Lisa McLean, Piper Smith Basham/Watton (your ref: 31681); (2) Mr Silverstone and Ms Ayesha Salim, CKFT (your ref: 32354).
