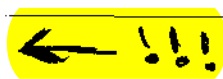

1. A pparently victim forst came into contact with the victim on 30th January, when the victim confronted the suspect by asking iif he lived at the flats. She was told to mind her own business. On the 1st february at 2245 the victim's door bell rang when shhe got there the lift door closed and when up to where flat 35 is located. On 15th February at 2345hrs a stone or small object was thrown at her windows from the street. Yesturday on 17th February the victim had about ten phone calls in the space of five minutes from 2150. She states that because she was anxious she did 1471 and there had been calls at 2228 and 2343.

Two other esidents have suffered the same way and it has been the suspect. All three people are in dispute over service charges and it is believed that the suspect has some interest in the ownership of the block.

A few minutes later I rang the office apologising profusely, she told me that my call out of the blue had overwhelmed her and that she could now remember making the calls on her way home one evening, she was extremely apologetic at having caused further investigation of this matter and apologised for causing any further anxiety to Ms Rawe.

I have left messages asking Ms Rawe to contact me to update her. This matter is complete and the papers are now FOD'd at BC.

Ms Rawe was updated having called BD on Thursday, I explained that as Mrs [redacted] had already been warned for making calls before and after the three made from the hotel, no further action would be taken against her and that was the end of the matter.
