1. Immediate action - the victim and the witness today were going into the victim's flat and the suspect was walking out of her flat and shouted 'Go fuck yourself!'. The victim said 'There are other people here'. The victim then walked into the lift to his flat.

The suspect say 'Go fuck yourself' to the victim when she sees approx 3 or 4 times. The suspect says this in the public area of the lobby and at it is very embarrassing for the victim.

The suspect has been living there for approx 20yrs and the victim has been living there for approx 2-3yrs. Letters from the Managing Agents for a service charge to the flats. This letter has been sent to all the residents to pay for this refurbishment. The suspect seems to think that the victim is behind the company who has sent these letters asking for money. The victim states that the reason why she is being like this is because she does not want to pay. The victim is annoyed that she is using this foul language towards him. The victim has not actually spoken to her about this face to face.

This verbal abuse started in November 2002. The suspect on her work headed paper wrote letters accusing the victim of theft. These letter went to the
