Dear Ms Rawé

The Local Government Ombudsman has asked me to consider your complain against the London Borough of Kensington and Chelsea and to write to you. We have spoken by telephone and I have also spoken to the Council about the accounts which you are seeking.

Your complaint, as I understand it, is that the Council has not taken action to assist you to obtain year end accounts for Jefferson House, Basil Street. The Council has now sent me copies of the accounts which it had been told would be sent to you during week commencing 8 November 2004. I enclose a copy of these accounts for you.

2002 & 2003 were enclosed.

It seems to me that this is the remedy you sought in making your complaint and so it is my preliminary view that the complaint should be considered settled.

Corrupt hypocrite

However, I will not come to any final view until you have had the opportunity to comment on what I have said. If you have comments which you think may be relevant, please send them to me within the next three weeks and I will consider them. If I do not hear from you by then we will discontinue our investigation and, as required by the 1974 Act, I shall send a copy of this letter to the Council's Chief Executive.


With reference to my earlier letter today, I am pleased to inform you that the Accountants have now completed the Accounts for the year ended 31 December 2003 and have faxed us a copy.
