I spoke to Jeremy this afternoon.

As I captured in my [17.01.08](#) Grievance, **lines 1086 to 1092:**

I had told Julie Bennett about some instances of [harassment and intimidation](#) undertaken / instigated against me by [Andrew David Ladsky](#) and my experience (and that of other residents) with [the local police mafia of Kensington, Chelsea and Notting Hill](#).

I hold the view that 'the suggestion' was the outcome of conniving between Bennett, Peter Bassett and Jeremy Nelson, head of KPMG Security – by anticipating that I would tell Bennett

about my experience with the local police mafia. (My first meeting with her on [22.02.07](#)).

As stated in my above email, I spoke to Nelson him on 23 Feb 07. The outcome was 'an offer' to accompany me to Kensington & Chelsea police. I did not follow this up, mainly because of my, by then, extensive first-hand experience with these corrupt to the core police stations.

In addition, I had found Jeremy Nelson's manner unpleasant – and concluded from this that he was an ex. cop, still with strong ties with the police.

I got further confirmation of this on 27 Apr 07 - as I reported in my [17.01.08](#) Grievance, lines 1138 to 1153, and as discussed under section 3.4 [KPMG page](#) – (to which I have also added other comments, not included in my Grievance).

On that day, he phoned me to say that he had spoken to [Kensington & Chelsea police](#), and that the police "is not going to take the matter further (*). Isn't that good news?"

(*) i.e. its highly vicious, malicious, defamatory, xenophobic, racist accusations against me to my website Host in its emails of [16.03.07](#) and [20.03.07](#) accusing me – without ever contacting me, and without providing any evidence – of, among other, having "committed a crime" and being "a Nazi, because of my franco-german (sic) origin" ([Overview # 13](#)).

By then, I had not seen the [PACK OF LIES](#) so-called "crime report" it had concurrently processed against me, [in Mar 07](#)).

At the suggestion of Peter Bassett, I sent Nelson the police emails with my [03.04.07](#) email).

As I also reported in [my Grievance](#), Nelson did not 'like' my laughing at that and, more to the point, because he realised that I saw through the game: Nelson had not contacted me in 2 months, so, why now?

ANSWER (also stated in my Grievance): Three days previously, on 24 April, on the home page to [my website](#), I had given prominence to the action by the police and stated

"At the date of the update of this page, there has been NO follow-up by [Kensington and Chelsea police](#) since"
