

So please, can you put pressure on getting this addressed ASAP.



I am really sorry but this is now with Global IT and we have asked for a response as quickly as possible.

Translation: We are ALL enjoying this A LOT.

The evil, sadistic, perverse monsters were getting their kicks from seeing me sobbing uncontrollably at my desk from 2 Apr 07 onwards, for the best part of April:

- section 4.1 [KPMG page](#);
- header 4.4 and 4.5 of my [17.01.08](#) Grievance (section 11);
- paras 9 & 10 of my [03.04.08](#) Claim against KPMG – in relation to which, in [its PACK OF LIES of Defence](#), under para.12(2), it denied “*exposing [me] to extreme distress*” .(section 6, # 4, [KPMG page](#))

And, desperate to CONTINUE getting their sadistic kicks, they FAILED to take action...until 23 Apr 07 when, [having made me sign a letter](#) ‘agreeing’ to be barred from accessing the internet, they finally restored my access: [24.04.07-9h10](#) email from Peter Bassett, partner:

“As I mentioned to you yesterday, it has been agreed that while IT cannot put in place the necessary arrangements, your intranet / internet access will be restored, subject to your signing a letter in which you undertake not to go outside the permitted sites”

“while IT cannot put in place the necessary arrangements” = **A COVER UP** that would ‘support’ KPMG’s claim that it had been trying ‘ever so hard’ to resolve ‘the issue’. (It was followed by a [01.05.07-10h00](#) email from IT that had the same objective)...

...as **KPMG had DELIBERATELY CUT ME OFF FROM THE NETWORK FOR 24 DAYS** ([23.04.07-11h34](#) email) (section 4 [KPMG page](#)).

The 23 Apr 07 letter issued ‘by’ [Jeanette Dunworth, HR \(= Peter Bassett\)](#) that Bassett asked me to sign (I returned with my [25.04.07-13h45](#) email) – states:

“...following a meeting attended by you, Jeanette Dunworth and me on 30 March 2007, you were informed that your internet and intranet access would be restricted.”

NO! Jeanette Dunworth, HR, **ONLY mentioned the internet** - as I reported under lines 134-

135 of my [17.01.08](#) Grievance:

*“Because of [[Andrew David\] Ladsky](#) [FALSE, MALICIOUS] communication [to [KPMG](#) against me] it had been decided that, **“to protect [me] and KPMG, it would be best that [!] no longer have access to the internet”***

WHY restrict my access to the intranet i.e. the internal sites? (as I stated under lines 233-236 of my Grievance).

To claim that this is what I was told would prove that KPMG had been intent on stopping me from doing my work...which is exactly what **‘[The Best Company to Work for](#)’ DID - over a 24-DAY period! A FACT that is ADMITTED in the letter.**

“Since then you have been unable to access the external internet or the global intranet”; [= the internal sites]

“in order to enable you to carry out your day to day work” ;

“decided to reinstate your access solely for the purposes of allowing you to do your job”

...providing an **UNDENIABLE ADMISSION** that **KPMG HAD DELIBERATELY PREVENTED ME FROM DOING MY WORK.**

What was KPMG doing behind this?

Demonstrating its unbelievable level of moral depravation ...it was ‘ever so kindly’ “offering” me access to its “health services” (**section 5 [KPMG page](#)**) e.g.

2 hours after my above emails: **05.04.07** email from **Nuffield Proactive Health** “offering” me a “Health & Wellbeing Assessment”

And **KPMG kept pushing other of its “specialists” at me** – trying to get me to bite on one of the hooks – see my summary in the **08.05.07** email from BUPA Wellness KPMG...

...while, of course, CONTINUING to subject me to **Criminal Psychological Harassment** – **in order to achieve its VERY SINISTER objective**: my Comments in my **14.02.07** Draft Notes of the 13 Feb 07 meeting with Peter Bassett and Jeanette Dunworth – and in relation to which Bassett had refused to issue me with notes.






- my [17.01.08 Grievance](#) to KPMG, and its [22.05.08](#) complete rejection of it (**section 11 [KPMG page](#)**);
- my transcript of my secret recording of my so-called 'performance appraisal' meetings on [09.10.07](#) and [24.10.07](#) (**sections 8.1 and 9.1 [KPMG page](#)**);...
