



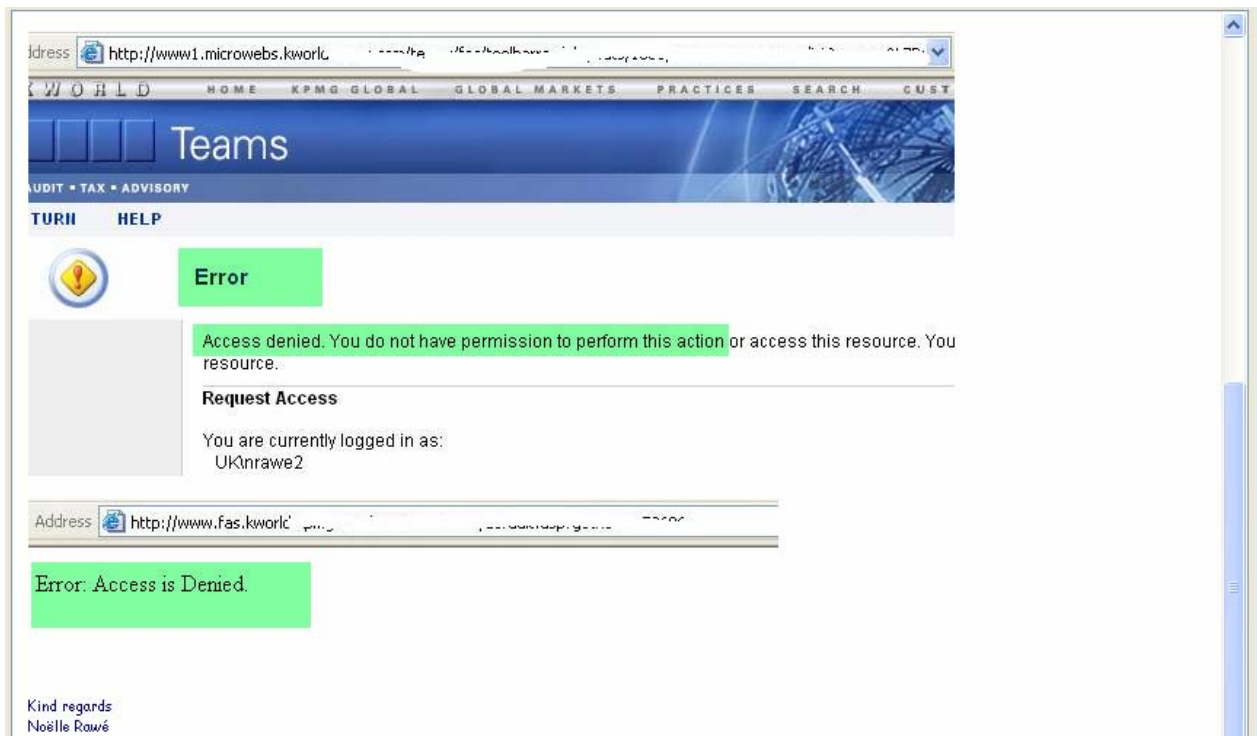

- [10.04.07-12h08](#), repeating the same thing;
- [11.04.07-9h49](#), yet again, repeating the same thing, and...
- ...'the reply' on [10.04.07-16h14](#): "*will look at it when I can*".

**REALITY:** They were **ALL** getting sadistic kicks from seeing me extremely distraught, and sobbing uncontrollably at my desk:
