This letter stinks of yet another set-up by [MULTI-CRIMINAL PSYCHO RACHMAN ANDREW DAVID LADSKY](#) – as part of HIS ONGOING BLIND DETERMINATION TO “GET [ME]” (as he first told me on 3 Jan 03: “*I am going to get you this year!*”) – and of his doing this IN COLLUSION with his [Kensington police henchmen](#).

(The previous use of plants by [Ladsky](#) and [his Kensington police henchmen](#) – with the objective of trapping me, etc, - are summarised under [Persecution # 2.8](#).

As can be seen from the summary, in terms of communication from Ladsky / instigated by him, this latest letter makes it 5+ individuals used to send me communications.

The previous one was a [04.11.13](#) letter 'from Irene'. The one before that was a [01.08.12](#) letter 'from Denise', that had been preceded, 2 years previously, by [emails \(My Diary 6 Aug 12\)](#).

THE OBJECTIVE OF THIS LETTER IS TO CAUSE ME FEAR AND ADD TO [THE CRIMINAL PSYCHOLOGICAL HARASSMENT \(Persecution # 1\)](#)

This letter 'from Jane' is dated '10 Oct 13', but was **ONLY DELIVERED** to my apartment on 3 Feb 14 i.e. 4 MONTHS LATER! As can be seen on the envelop, 'very conveniently' most of the postmark, and hence the date of posting, *cannot* be seen.

The '4-month-delay' added to the following events lead me to the conclusion that this letter, sent 1st class, was **posted on Friday 31 Jan / Saturday 1 Feb 14**.

1 The statement of “[having the door smashed in](#)”

As I report in [My Diary 17 Jan 14](#) (i.e. 2 weeks previously), [Andrew David Ladsky](#) / one of his mafia got access to my apartment to throw a lot of water on my bathroom floor.

[Ladsky](#) / his mafia could have ONLY obtained access to my apartment through my 'security-lock' supplier, [Banham](#).

In my [03.02.14](#) letter to [Banham](#) (followed by an [18.02.14](#) chaser letter), I reported the outcome of my visit to its showroom on 30 Jan 14 (*) leading to the conclusion that [Banham HAD opened the door to my apartment “at the request of the \[local\] police”](#). (*) NOTE that the '10 Oct 13' letter was sent 24 / 48 hours after my visit to the showroom ([Ladsky](#) and [his police henchmen](#) are tracking me, hounding me, etc - on a daily basis: [Persecution # 2](#))

In its [20.02.14](#) 'reply' (to which my Comments are attached) [Banham denied doing this](#), as well as [denied giving a key to Ladsky](#). **This is very clearly NOT TRUE: BANHAM DID PROVIDE ACCESS TO MY APARTMENT TO [LADSKY](#) / HIS MAFIA.**

Hence, I read the objective of the statement: “[having the door smashed in](#)” as the CRIMINAL PSYCHOS PILING ON THE FEAR AND [CRIMINAL PSYCHOLOGICAL HARASSMENT TACTICS](#), while adding to their sadistic kicks i.e.: ‘[dare to fight back against your \(criminal\) landlord \(and his criminal supporters\)](#)’ – and your door will be smashed in’. HOWEVER: ‘as you know from our 17 Jan 14 entry, we don't even need to smash the door, as we can just come in as we please’.

2 The statement: "***I tried to go on your website...but access was denied***"

There were NO access issue to my website 'in Oct 13'.

The criminal psychos in the British State interfered with my website IN FEBRUARY 2014.

(They interfere with ALL my other means of communication ([Persecution # 3](#)) - so, why not this as well - as [Ladsky](#)'s henchmen in Kensington police FAILED in their 2007 attempt to get it closed down ([police Overview - Section 3](#)))

TRIGGER? 'My daring' to put a [Summary of my case](#) on the site on 25 Jan 14.

And **perhaps also** my [10.02.14](#) document to [Ladsky](#)'s **criminal 'managing' agents, [Martyn Gerrard](#)** – challenging their repeated fraudulent demands – that undermines their, [Ladsky](#)'s, and his supporters' ([Persecution # 6](#)) plans?

(It is abundantly clear from the evidence I captured in the [10.02.14](#) document that the mafia and its supporters are preparing their next attack).

3 The reference to "***a small leaflet***"

This does not make sense.

I am not bothering with the rest of the letter.

This latest letter confirms – YET AGAIN - that [Ladsky](#) has NO difficulty finding a literally endless number of individuals only too happy to help him in his criminal activities (other examples under [Queen's Bench # 6.1](#)).
