3. Lynton does NOT do the work

At least in relation to the works said to be carried out at [Jefferson House, 11 Basil Street, London SW3 1AX](#):

3.1. Re. "Boiler works"

IN SPITE of:

- the **03.10.13** letter from [Martyn Gerrard](#) quoting "*an estimate in respect of the boilers works from Lynton Services Mayfair (1994) Ltd*"
- the **03.04.14** letter from [Jon Wolbrom, Martyn Gerrard](#), continuing to claim that the works "*will be undertaken by Lynton Services*"...

...Lynton Services **actually sub-contracted the works to** [CMB Services](#).

3.2. Re. "water hygiene treatment"

IN SPITE of:

- the notices of "*water hygiene treatment*" headed 'Lynton Services' (**28.03.14** ; **24.04.14** ; **08.05.14**) – a sub-contractor was ALSO used.

Conclusion: = **mark-ups added to the price...**

...**which translate into how many 1000's of £s??...**

...added to the "**10% management fee of £13,500**" by [Martyn Gerrard](#)...

...– for "*managing*" what? NOTHING! as it sub-contracted to a company that then sub-contracted the works!

HOWEVER: As explained in my **10.02.14** letter to [Martyn Gerrard](#) (it had NOT acknowledged, MORE THAN 4 MONTHS LATER) – **I have already paid for "the boiler"**. (Also discussed under e.g. [Notices # 5.2](#))
