Dear Ms Saunders,

In its 13th July 2016 edition, The Telegraph had an article, "[Prosecutions for hate crime against disabled people surge by more than 40 per cent in a year](#)" - in which it quoted you as saying:

"My message is that a hate crime is exactly that - a crime - and will not be ignored..."

"...no one should simply think that this abuse - on or offline - will be dismissed or ignored."

The article also reported:

"The CPS also announced that it would engage more closely with community partners and would be updating the legal guidance for each strand of hate crime."

On the same day, on its website, the BBC had an article, "[Nottinghamshire Police records misogyny as a hate crime](#)" – stating:

"Harassment of women is to be recorded as a hate crime in a bid to tackle sexist abuse."

"Nottinghamshire Police said it would expand its categories to include misogynistic incidents."

"It means abuse or harassment which might not be a crime can be reported to and investigated by the police, and support for the victim put in place."

"Chief Constable Sue Fish said: "What women face, often on a daily basis, is absolutely unacceptable and can be extremely distressing"

"Nottinghamshire Police is committed to taking misogynistic hate crime seriously and encourages anyone who is affected by it to contact us without hesitation."

"The force defines misogyny hate crime as: "Incidents against women that are motivated by an attitude of a man towards a woman and includes behaviour targeted towards a woman by men simply because they are a woman."

Chief Constable Susannah Fish ([copied](#) on this letter) is absolutely right, and I commend her on her initiative.

But: how would she, and how will you react when heinous hate crimes are perpetrated by individuals in the public sector – as has and continues to happen to me?

As discussed on my website, www.leasehold-outrage.com, since 2002, I am the ongoing victim of crimes that are motivated by hate, with misogyny being very clearly at the base.

I am being targeted because: (1)- I 'dare' to stand up against organized crime; (2)- in addition to being a woman, I am an immigrant (since 1968) of Franco-German origin (but of British nationality for many years); single; no family in this country; source of income: through employment, which my enemies have ensured [ended](#). Hence: assumed to be unable to fight back against extremely abusive, life-destroying treatment.

As discussed on the [Home page](#) to my website, and in the [case summary](#), since 2002, my attackers and abusers have been – and continue to be - men (with a supporting cast of women, including in the public sector, who act as their henchwomen).

Those who kick-started the horrendous, life-destroying treatment against me are **my landlord, [Andrew David Ladsky](#), and his gang of racketeers**. They decided that I (and fellow leaseholders, at Jefferson House, 11 Basil St, London SW3 1AX), would be made to pay for the construction of [a penthouse](#) and addition of other apartments – for which we are not liable – so that Ladsky could make a multi-million £ jackpot; (my website: [Advisors page](#); [Sale of flats page](#); [Definitions page, under Extortion](#)).

'Little me' 'dared' to challenge them.

They were followed by **police officers in the local Kensington & Chelsea police stations** ([Police page](#)) who immediately rallied to ensure the protection of Ladsky, following [my 2002 complaint of harassment against him](#) – telling me (in relation to my receiving numerous anonymous phone calls): "[You won't be able to prove a link with Andrew Ladsky](#)".

They did the same thing following complaints of [harassment](#) against him from several of my fellow leaseholders ([Police page # 4](#)) – including from the woman who was running the residents association for the block, whom Ladsky subjected to horrendous, sustained harassment because she (also) 'dared' to stand-up to him ([Head Residents Association page](#)).

(The police's 'response' to her complaint? "*Chelsea police advised her off the record to fold her tent and go*" (as reported to me [by a fellow leaseholder](#))).

In my case, Kensington, Chelsea & Notting Hill police then switched to attacking me.

In 2003, following 'a complaint' against me by Ladsky - by processing a pack of lies so-called "[crime report](#)" against me of a "Confirmed" "Substantiated Offence of Harassment" – [while denying me the right to defend myself against the scurrilous accusations](#).

It also sent me [a threatening letter](#) telling me, in effect, that I had better shut-up and not challenge 'dear Mr Ladsky' "*or there may be further consequences*" ([Home page # 16](#)).

In 2007, following another 'complaint' against me by Ladsky, whose objective was to secure [the closure of my 'inconvenient' website](#), it processed another pack of lies so-called "[crime report](#)" against me, containing highly vicious, malicious and defamatory accusations against me. This time, it did not even contact me. (I only found out about the report because I submitted [a Subject Access Request](#). Needless to say that [the version](#) I was sent was highly redacted).

Instead, with the objective of obtaining the closure of my website, in its malicious, libellous, xenophobic emails to my website Host, it accused me – without *any* evidence in support - of having 'committed a crime' by stating: "*Website with anti semitic (sic) views*" and: "[I am the police officer dealing with this crime](#)"; (a doubly false claim, as it was sent by a Simon J Dowling, '[Community Support Officer](#)').

From being challenged by my website Host who asked: "*Are you aware that there are laws against making false accusations?*" – ['he' replied](#): "*If you are unable to close the site down I will let the victim know as there is nothing we as a police force can do except class it as a racist incident.*" – while *still* not providing any evidence in support of the accusations.

'He' also continued to brand me "*a Nazi*" "*because of [my] franco-german (sic) origin*".

For obvious reasons, these packs of lies "*crime reports*" are a source of extreme anguish and distress to me – added to the fact that they are accessible by more than 50,000 people. The

police is thus defaming my name, character and reputation - on an ongoing basis since 2003 - among a very large audience – and, no doubt, rallying support against me, as well creating hatred towards me. [Summaries under [Data Protection Act](#)]

As summarised on the [Home page under # 18\(1\)](#) (extended summaries under [Doc library # 4](#)), my wanting to stop the illegal processing of the “*crime reports*” resulted in my having to engage in long, drawn-out battles, all the way up to the level of the then Met Commissioner, Paul Stephenson, the then Home Secretary, Alan Johnson, as well as IPCC.

As *all* these men failed to take action – it led me to file a [19 Apr 11 High Court](#) Claim against the Metropolitan Police Commissioner.

As had happened with the **judiciaries**:

- in the local courts ([West London County Court](#); [Wandsworth County Court](#)) (all men, bar two women):

(1)- in 2002-04, in relation to a fraudulent [29 Nov 02](#) claim filed by Andrew David Ladsky’s solicitor, [Lanny Silverstone, CKFT](#), against me [and 13 other apartments](#);

(2)- [in 2007-08](#), in relation to the [27 Feb 07](#) fraudulent claim filed against me by Ladsky’s solicitor, [Jeremy Hershkorn, then at Portner and Jaskel](#);

- in 2009, in the Supreme Court Costs Office, when I filed [an Application](#) to get back at least my costs, following the Feb 07 claim ending in a [6 Jun 08](#) Notice of Discontinuance of “*All the claims against [me]*”;

they (in the [High Court’s Queen’s Bench Division](#)) (one master, and two judges, including a woman) *all* suffered from ‘sudden attacks’ of extreme blindness to the very damning evidence, as well as amnesia about the rule of law. [My [17 Oct 11 Request for oral hearing](#)]

The many things they turned a blind eye to include the lies by the Met Commissioner in his [Defence](#) about my experience, in Oct 10, when I made seven vain attempts to get [Kensington & Chelsea police](#) to investigate my well-documented complaints of [harassment](#) against two men who were stalking me. [1st man ; 2nd man]

I was able to provide undeniable proof of the Commissioner’s lies - as I had secretly recorded a conversation with one of the police officers. I did this with my [14 Jun 11](#) Reply to parts of the Defence, and by supplying, to each of the Defendants, as well as to the court, a CD-ROM with a recording of the conversation, as well as [a transcript](#).

[Tribunal]

The outcome of my dealings, in 2002-03, with [the then London Leasehold Valuation](#)[▲], amounted to the same thing: blatant siding, assistance to, and protection of Andrew David Ladsky and of his gang of racketeers.

(Summaries of events with the courts and tribunal are on the [Definitions page, under Kangaroo courts](#)).

My [19 Apr 11](#) Claim also included claims against the [Home Secretary, then Theresa May](#), for having me [unlawfully under ‘surveillance’](#).

[Overview # 12]

Typically for Theresa May (¹), with the assistance of a High Court master (Master Eyre), she rejected my Claim (my website: [Other courts # 6](#)).

Having endorsed the conduct of the police (in addition to my Claim, I copied her on all the related documents, including [my witness statements and supporting evidence](#)) - she then continued to repeatedly issue illegal 'surveillance' warrants against me – thereby ensuring the continuation of the persecution against me ([Home Office page # 3](#); [Persecution page](#)).

As reported under [Home Office # 3.1\(4\)](#), incensed by her hypocritical comments at the Sep 14 Conservative Party conference, I wrote her a [25 Nov 14](#) letter in which I contrasted her claims with my case.

[I am delighted Keith Vaz got his comeuppance: "[Keith Vaz resigns as chair of home affairs select committee](#)" Guardian, 6 Sep 16]

Under separate post for each, I also copied 19 individuals on the letter: the [then Prime Minister David Cameron](#); Chris Grayling, then Secretary of State for 'justice'; the leaders of the main parties; each of the 10 members of Parliament's Home Affairs Committee; Sir Bernard Hogan-Howe, Met Commissioner; Boris Johnson, then head of the Mayor's Office for Policing. I repeated the same mailing two weeks later.

I did *not* receive an acknowledgement from Theresa May, nor from any of the others. In fact, the only 'response' has been a continuation of the persecution by the police and related agencies – that includes their continuing to operate hand in glove with the Ladsky resources. (I have more evidence to add to my website). [See e.g. [My Diary 2016](#)]

Knowing that it has carte blanche to do as it pleases, the relentless attacks by [the Ladsky gang](#) continue. It includes by [Martyn Gerrard](#), the so-called 'managing' agents for Jefferson House, who, since 2011, has been sending me ever-growing fraudulent demands (now standing at [over £45,000](#)) – while ignoring *all* my correspondence.

It is glaringly obvious that there is *absolutely no point* my calling on the police to take action against the criminal activities, including the ongoing [criminal psychological harassment](#); nor if I am physically attacked. [My Diary page](#) includes a summarised version of examples of [harassment](#) I am being subjected to:

- Under # 2, the fact that, [since 2005](#), *all* my means of communications are unlawfully monitored and interfered with – resulting in, among other, greatly reducing the frequency of my contacts with my family and friends in France, as well as affecting the content of these contacts. [e.g. my [19.07.11](#) Witness Statement to Theresa May; [Queen's Bench # 6](#)]

¹ As Aida Edemariam of The Guardian reported in her 13 July 16 article, "[Theresa May is no liberal – and her rise to PM is no cause for celebration](#)": "As home secretary she has been zealous in her pursuit of the government's harshest policies."

Referring to immigration cases: "...the Home Office using a sledgehammer to crack a sesame seed. No case, it seemed, was too small to prosecute, no judicial decision water-tight enough not to challenge, all the way to the highest courts in the country..."

"...the president of the upper tribunal noted that he had "the impression that the secretary of state [for the Home Office], as a matter of routine, applies for permission to appeal in every deportation appeal [resolved in favour of the appellant]"

"These applications, it seemed to him, were often generic, not engaging with specific cases but lodged simply to try to ensure that no appeal could ultimately be successful."

Referring to a particular case: "Because the government kept refusing through higher and higher courts, the case eventually involved 18 barristers and cost well over £600,000".

Ms Edemariam also refers to the "[Go home](#)" vans Theresa May had circulating in London ("[Go home billboard vans not a success, says Theresa May](#)", The Guardian, 22 Oct 13). This will have certainly encouraged "xenophobic abuse".

- Since 2009, I am living with a death threat hanging over my head: “*Enjoy your life. You don’t have long to live*”. (Yes, I reported this endlessly, including to the Met Commissioner and Home Secretaries).

This death threat was reinforced [in 2014 by one of the local police](#) (had to be) positioning himself in front of my windows, wearing a T-shirt stating: “*120% darkside justice bounty hunter*”.

It is the title of a track that includes the lyrics: “*Murder, assault, wild out of control type. I am obsessed with death... No remorse, mega force records seek and destroy. We kill em all, zip up the bag, bring em to the morgue...Going against me? Victory is impossible...Murder for no reason other than monetary. The devil made me do it, it's involuntary...*”

- I am living under siege-like conditions, barricading myself at night, as well as unable to leave anything of importance to me in my apartment - as [Kensington police](#) has ensured that [Ladsky was provided with a key to my apartment](#).
- I am being subjected to [harassment](#) in my home e.g.:

2.4]

- (so far) 9 malicious escapes of water, including [a complete flooding of my apartment](#), as well as [over 100 litres of water poured through a light fitting in my bathroom ceiling](#). (I need to change my bathroom but, I am obviously not prepared to spend several thousand pounds to see it all destroyed. Outcome: since 2009, I wash myself in the kitchen sink, and flush the toilets by emptying buckets of water from the kitchen tap);
- in the middle of the night, a man banging on my windows, while talking loudly and laughing with his accomplice;
- on numerous occasions, hosing of my windows in the middle night;
- on several occasions, I have had the water, electricity and heating cut off in my apartment.

[Persecution

Etc., etc., etc.

There I am: a law-abiding individual who, over the years, has paid over £500,000 in tax, believing what I was told: that the State was there to ensure my protection, as well as justice. Instead, not only has it denied me these rights, for the benefit [of criminals](#), it has destroyed my life by grossly abusing its power.

No doubt, if I were e.g. Mrs Chermukhin, wife of the Russian banker and former deputy finance minister under Vladimir Putin, who paid £160,000 in return for a tennis match with David Cameron and Boris Johnson ⁽²⁾ – I would not be treated as I have, and continue to be.

Ms Saunders, I have outlined some elements of my case to you to provide you with the opportunity to endorse your assertion: “*Hate crime will not be ignored*”. Will you, as Director of Public Prosecution, take action?

In addition to Chief Constable Susannah Fish, ([I am copying her](#) for her information), I am also copying this letter to:

(1)- Chief Rabbi Ephraim Mirvis; (2)- Archbishop Justin Welby; (3)- Bishop Stephen Cottrell; (4)- Chief Inspector Gareth Parkin, Manchester police; (5)- United Nations Human Rights Chief, Zeid

As can be seen from my letter, the reasons are: like you, they have recently commented on hate crimes; although there is some overlap in my letters, I also focus on different aspects of my case.


