Dear Mr Cameron

ENSURING THAT THE NECESSARY STEPS ARE TAKEN SO THAT THE PARLIAMENTARY OMBUDSMAN CAN CONSIDER MY COMPLAINT AGAINST THE COURT SERVICE AND THE LEASEHOLD VALUATION TRIBUNAL

On 26 May 2009, in the televised part of one of your speeches, you said:

"Voters are furious... Attitudes have to change big time. Politicians have to change"

"There needs to be a massive redistribution of power – from the powerful to the powerless"

In light of my experience, since March, with one of your members, Sir Malcolm Rifkind - which is detailed in my enclosed letter of 15 June 2009 to Mrs Ann Abraham, Parliamentary Ombudsman – I, the so-far very "powerless" have opted to kick-start the implementation of your policy of "Redistributing the power from the powerful to the powerless" by directly referring my complaint to the Parliamentary Ombudsman - in the process going over Sir Rifkind's head, as he has evidently decided that the Parliamentary Ombudsman should not consider my complaint against the Court Service and the Leasehold Valuation Tribunal.

Why? I conclude that, as with the many other parties who, since 2002, have consistently and repeatedly told me – the law-abiding, innocent victim of organised crime - to, in effect, 'get lost', the motive is to protect 'tribe members' who have helped a bunch of crooks i.e. Andrew Ladsky et. al. to – so far - get away with defrauding leaseholders of c.£500,000 in order to generate a multi-million Pound jackpot. This fraud took place with assistance from, among others, Government controlled departments in Sir Rifkind's constituency of Kensington & Chelsea: courts, police and council.

(I note that Sir Rifkind appears to be in the habit of blocking the 'little people' from getting redress from Government departments e.g. from The Sunday Times, 31 May 2009 "In 1995...when Malcolm Rifkind was then Foreign Secretary, [he] ruled that [Richard Tomlinson's] case (who had been "sacked by MI6 without explanation") could not be heard at an industrial tribunal. Tomlinson was stung by the apparent injustice").

I trust that your Office can liaise with Sir Rifkind (copied on this letter) to ensure that the necessary steps are taken so that Mrs Abraham's Office (copied on this letter) can consider my complaint against the Court Service and the Leasehold Valuation Tribunal.
