2. Your claim of losing my Birth Certificate

I am absolutely outraged by this. The fact that:

- this highly important document - that can be used for identity fraud - has been 'lost';
- my repeated demands for its return, over the last 4 months, were studiously ignored;
- my being messed around since last November, and the evident sadistic pleasure taken in doing it – by asking me: for things I have already done; chasing me for decisions, knowing I have not received the necessary information I requested (as detailed in my [15th April 2012](#))...

...lead me to the glaringly obvious conclusions - bearing in mind my horrendous and very traumatic experience – as *the innocent victim of organised crime* - [with the State sector since 2002](#) (Her Majesty's: [courts](#), [tribunal](#), [police](#), [my MP](#), [local council](#), [Parliamentary](#), [Legal](#), and [Local Government](#) Ombudsmen, etc.) that:

- (i) somebody has ordered the retention of my Birth Certificate; **WHO?**

- (ii) it is being retained obviously for malicious intent - perhaps given to [my landlord, 'Dear Mr Andrew Ladsky'](#)? - as his fraudulent, upon fraudulent demands ([currently standing at over £31,000](#)), as well as other forms of ongoing harassment and persecution are not achieving his longstanding objective of destroying me;
- (iii) [in tandem with 'Dear Mr Ladsky'](#) - it is part of the extremely cruel, vicious, sadistic '[retribution package](#)' that has and continues to be dished out against me [since 2002](#) by various individuals in the above State sectors – to which can now be added the Pension Service. WHY? For no other reason than my 'daring' to stand-up for my so-called 'rights' in the face [fraudulent, upon fraudulent 'service charge' demands and court claims](#); false, malicious and highly vicious accusations against me in [so-called "crime reports"](#) ⁽¹⁾ - in the process, 'daring' to stand-up to them and their protégé, 'Dear Mr Ladsky'.

The Pension Service adds to the ever-growing rank of the so far hundreds of individuals who, every step of the way since 2002, have automatically aligned themselves with 'Dear Mr Ladsky' - against me. Indeed, in addition to the State sector, there are also [lawyers](#), [surveyors](#) and their so-called 'regulators'.

There is also, on the medical side: (i) my doctor of 37 years who claimed to have "*no record of prescribing me tranquilisers and anti-depressants*" [in April 2007](#), time at which I was being subjected to horrendous victimisation at work (of course, 'courtesy' of 'Dear Mr Ladsky'); (ii) [the 'specialist'](#) who could not wait to get me locked-up – at the time I was due to file my Witness Statement in response to [the second fraudulent claim against me](#) by 'Dear Mr Ladsky' (he then [dropped ALL of the claim against me](#)); (iii) another 'specialist' who could not wait to operate on me (a French doctor simply could not see on what 'the decision' was based).

To these are added [work colleagues](#) who joined blindly in the victimisation regime over a period of 10 months – leading me to resign; acquaintances and so-called 'friends' who were clearly acting on behalf of the very large Ladsky camp.

While, mercifully, at times, I still come across genuinely kind hearted English people, considering the above, very substantial sample size, as well as cross-representation, I cannot help asking: what does that say about the profile of the people of this country?

Well, if I suffer identity fraud, I'll know where it comes from.
