Dear Secretary of State,

**Your department is withholding from me – maliciously – the payment of £100 Winter Fuel Payment – amounting to a continuation of the persecution started last year.**

In its, attached, [18<sup>th</sup> November 2012](#) letter (a Sunday) (<sup>1</sup>), your Pension Service department, at PO Box 1005, Newcastle Upon Tyne NE98 1WZ, states:

*"Winter Fuel Payment: £100. This payment is paid at a shared rate because there was another person living in the household also entitled to this payment".*

My [6<sup>th</sup> December 2012](#) (copy of post receipt of 'Recorded Delivery', attached (<sup>2</sup>)) handwritten reply, captured on the letter, was:

*"That's news to me!!*

*EXACTLY WHO do you assert was "also living in the household"?*

*= Continuation of the persecution and tormenting by continuing to align yourselves with [the Andrew David Ladsky organized crime mafia](#) and [their other supporters](#); [MY DIARY 9 May 2012](#) – [www.leasehold-outrage.com](#)"*

To date, I have *not* received a reply. On Friday 4<sup>th</sup> January 2013, my bank told me that *no* payment had been received. (The initial £100.00 payment was paid on 27<sup>th</sup> November).

This confirms further my above assessment.

You have NO right to withhold this £100.00 payment from me.

I demand that you ensure its immediate payment in my bank account.
