Dear Sir

- See his morally depraved 17.06.09 'reply', he will have written dripping with rage against me because of his top priority: protecting his tribe members: 'the brothers' (Persecution # 6).

- However, more than one year later, through conniving and collusion with the Parliamentary Ombudsman he succeeded in getting the rejection of my complaint: 2nd 'get lost' of 29.07.10 from the PHSO # 2

I, "THE POWERLESS", HAVE OPTED "TO TAKE THE POWER FROM THE POWERFUL" BY APPROACHING THE PARLIAMENTARY OMBUDSMAN

At the date of writing, I have not received a reply from you to my 8 May 2009 letter, and this in spite of my 8 June 2009 chaser letter.

On 26 May 2009, in the televised part of one of his speeches, your Party Leader, David Cameron, said:

*"Voters are furious... Attitudes have to change big time. Politicians have to change"*

*"There needs to be a massive redistribution of power – from the powerful to the powerless"*

Concluding from your silence and previous correspondence that you have evidently decided that the Parliamentary Ombudsman should not consider my complaint against the Court Service and the Leasehold Valuation Tribunal, I, the so far, very "powerless" have decided to kick-start the implementation of your Party Leader's policy of "Redistribution of power from the powerful to the powerless" by referring my complaint and surrounding exchange of correspondence with you to the Parliamentary Ombudsman – as detailed in my enclosed letter of 15 June 2009<sup>1</sup> to Mrs Abraham.

As to your reason for blocking me from getting access to the Parliamentary Ombudsman, I conclude that, as with the many other parties who, since 2002, have consistently and repeatedly told me – the law-abiding, innocent victim of organised crime - to, in effect, 'get lost', the motive is to protect 'tribe members' who have helped a bunch of crooks i.e. Andrew Ladsy et. al. to – so far - get away with defrauding leaseholders of c.£500,000 in order to generate a multi-million Pound jackpot. This fraud took place with assistance from, among others, Government controlled departments in your constituency of Kensington & Chelsea: courts, police and council.

(I note that you appear to be in the habit of blocking the 'little people' from getting redress from Government departments e.g. from The Sunday Times, 31 May 2009 "In 1995...when Malcolm Rifkind was then Foreign Secretary, [he] ruled that [Richard Tomlinson's] case (who had been "sacked by MI6 without explanation") could not be heard at an industrial tribunal. Tomlinson was stung by the apparent injustice").

Also enclosed, is my 15 June 2009 letter<sup>2</sup> to The Rt. Hon. David Cameron, MP, in which I ask for his assistance by liaising with you to ensure that the necessary steps are taken so that Mrs Abraham's Office can consider my complaint.
