**AUDITORS REPORT**


We have prepared the attached summary of costs, outgoings and expenses for the year ended 31 December 2000 from the receipts, vouchers and other documentation provided to us by the managing agents.

As previously reported, there is no separate meter relating to the electricity charged for the common parts. Records relating to the payment of electricity charges for the block generally were kept throughout the year by the managing agents and we have accepted their calculations of the charges for the common parts and the caretaker's flat for the year.

The annexed statement on the Contingency Fund shows the movements on the fund for the year ended 31 December 2000 and we can confirm that the balance of £104635.10 was held in a separate interest bearing account.

Subject to the above, it is our opinion that the attached schedule of costs, expenses and outgoings is sufficiently supported by receipts and other documents and represents a fair summary of the said costs, expenses and outgoings and when read in conjunction with the annexed summaries, shows how they are reflected in the service charge demands and specifies the amount payable by each lessee.
