Dear Tony

Thank you for your time today.

As, when I told you that [in April 2007](#) you had prescribed me medication, you said that it was not recorded on my file, and you did not ask me what it was, for the purpose of completeness of my file, please see attached one page containing:

- A copy of your prescription dated 16 April 2007
- A copy of the packaging for the 28 Citalopram tablets 20mg, purchased on 16 April 2007
- A copy of the packaging for the 40 Lorazepam tablets 1mg, also purchased on 16 April 2007.

As you can see: [I do keep a record of events!](#) (One of the lessons learnt from my horrendous, nightmare experience in this country [since 2002](#)).

You prescribed them because I was going through [a very traumatic time](#) with my then employer, [KPMG](#) (see [detail in Note 1 below](#)).

**That, VERY SICK, morally depraved individual, had been my doctor FOR 37 YEARS!**

What did he do when my then employer [KPMG](#) very clearly approached him (directly / indirectly) to determine what evidence I had in support of my [03.04.08 Employment Tribunal Claim](#) against KPMG - so that it could 'safely' deny taking UNLAWFUL actions against me: its [PACK OF LIES Defence](#), and its [22.05.08](#) 'response' to my [17.01.08](#) Grievance - **he fell over backwards to help by:**

**(1) - claiming he had "no record of seeing [me] 1 year previously; nor of prescribing [me] medication";**

**(2) – refusing to give me a referral to a psychiatrist** (for the purpose of evidence in relation to my Claim re. 'mitigating my loss') – using as excuse: "You should have come and see me before";

**(3) - asked me whether "[I] had recorded conversations at KPMG" (1) and,**

**(4) - had preceded this by telling me: "You should not have filed a claim against KPMG"**

It was none of his business.

**WHY did he do this?** My conclusion: A [Freemason \(Persecution # 6\)](#) (his clientele was very much [Establishment](#): 'Lord this', 'Lady that'),..

...added to the fact that **he is Jewish (2)**, 'like' [Andrew David Ladsky](#) (e.g. malicious, highly vicious, defamatory emails of [16.03.07](#) and [20.03.07](#) to my website Host from [Notting Hill police](#) – et.al. in [the Jewish-Freemason 'Brotherhood' \(Persecution # 6\)](#)).

**(1)**- Needless to say that I did not reply. As I only revealed at the time of launching [the KPMG](#)

[page](#) in 2015, I HAD recorded 2 very important ones: my so-called 'performance appraisal' meetings of [09.10.07](#) and [24.10.07](#). Considering the content, you can see why KPMG was keen to know whether or not I had recorded "conversations".

(2)- I had 'a Jewish doctor' for 37 YEARS! It sure knocks the claim by Ladsky and [his Kensington police mafia henchmen](#), in [the 2007 so-called "crime report" that "\[I am\] an anti-Semite"](#) ([Overview # 13](#))

Today I told you that I opted to not take the anti-depressant. The main reason is that I do not want to numb myself to reality. Up to 2002 I believed what I had been told: that there was a system in place to ensure the implementation of legislation and regulations; that the regulatory bodies were there to ensure that the professions complied with the legislation, regulations and codes of conduct.

Since then, my very extensive first-hand experience in the context of my problem with [my rogue landlord, Mr Andrew David Ladsky](#) (landlord/person fronting the ownership of Jefferson House, Basil St, where I own a leasehold flat) and his equally rogue aides ([lawyers, accountants, surveyors](#)) - added to my experience with [KPMG](#) - has led me to the conclusion that *all of it* is just window dressing, lies. 'Thanks' to my horrendous experience, I have 'seen the light'; the blindfold cannot be put back on my eyes.

Yes, I know what you said today about (one of the world's most dangerous) terror suspects being allowed to remain in the UK - out of concern for his Human Right for a fair trial. Seeing that 'makes me hurt' even more as it leads me to ask: [why is it](#) that 'I', the law-abiding, victim of crime, get treated as though I am the criminal - included by KPMG? [Why is it](#) that, since 2002, I have had all the doors repeatedly slammed in my face in spite of the overwhelming 'black on white' evidence I have against Mr Ladsky and his aides. [Why is it](#) that - unlike me - they are all, quite clearly, considered to be above the law in this country? [Why is it](#) that I am evidently viewed by all as having no rights, including Human Rights?

Regarding [Lorazepam](#), it proved very helpful in April 2007, and subsequently. However, not keen on ingesting chemicals, in an attempt to deal with the 'gigantic' emotional rollercoaster from going through sheer, utter hell, I aim to listen to a tape by [ ] (hypnotherapist, psychotherapist), and to meditate. [People tell me that they wonder how I have managed to survive this hell since 2002. I do too.](#)

#### **NOTE on events at [KPMG](#) in April 2007**

(The below events are captured in my [17 January 2008](#) grievance to KPMG (endorsed with a Statement of Truth), and in a summary version in my [3 April 2008](#) claim to the [Employment Tribunal](#) against KPMG).

At a meeting, on 30 March 2007, KPMG informed me that Mr [Andrew Ladsky](#) had approached KPMG claiming that my website ([www.leasehold-outrage.com](#)) "*contains anti-Semitic comments*".

I denied it saying that two weeks previously he had made the same false accusation to [Kensington & Chelsea police](#) and that the police had backed down when challenged by my website Host. [I supplied the emails](#) from the police as evidence. In spite of this, I was told that, "*to protect me and KPMG*", my access to the Internet would be immediately cut-off. Very trusting of KPMG and concerned that Mr Ladsky had brought his long-standing personal vendetta against me to KPMG, I did not challenge the rationale of the decision, nor asked for evidence of the accusation (it was not offered to me).

[By the time I returned to my desk](#), my access to the Internet had been cut off. In the process, my access to the majority of the Intranet (internal) sites had likewise been cut-off. As my work required constant access to the Intranet sites, it made it practically impossible for me to work.

This was an extremely traumatic time. [I kept highlighting my plight](#) as the impact on me was devastating: the automated messages generated from trying to access the sites made me feel as though I was a criminal. I was in tears at my desk practically every day during that period i.e. throughout April 2007, at times sobbing uncontrollably, feeling extremely distraught. In the first week, starting 2 April 2007, I found

it so difficult to cope with that practically every day, I ended-up leaving the office, taking time off as annual leave:

My perception of injustice was unbearable: [I am NOT the criminal. I am the victim of crime](#). Yet, I saw myself as being punished and further victimised for 'daring' to stand-up and fight for my rights – this time by [KPMG](#). And this was happening because of the 'say-so' of a party, to my knowledge, external to KPMG: Mr [Ladsky, my 'attacker' of six-year standing](#), desperately trying to get my website closed down because it exposes in great detail – and with a massive amount of 'black on white evidence' in support – the scam [he and his aides](#) implemented to defraud residents. (In February 2007 Mr Andrew Ladsky also filed another [fraudulent claim against me in court](#) – which is [still ongoing](#) at the date of writing this letter).

I felt the injustice even more acutely because KPMG had been aware of my personal situation since 2002 – and I had provided updates since then, [including in 2007](#). (In 2002, Mr [Ladsky had turned his harassment and intimidation tactics on me](#). Also, [his managing agent](#) had sent me an unjustified [£14,500 service charge demand](#). The combination of these factors meant that I found it difficult to cope with very demanding client work (I was a project manager on merger and acquisition assignments). It had led to my being transferred to a non-client facing role "*until [my] situation was resolved*". As my situation has been ongoing since, [I did not return to doing client work](#)).

Very hurtful as well was the realisation that my website host who does not know me believes in me and backs me up, whereas KPMG that had known me for 10 years and was aware of the history was 'siding' with Mr Ladsky and, by implication, his aides, against me.

Not surprisingly, my feelings of extreme distress also manifested themselves outside of work: I was constantly close to tears, often unable to hold them back. [ ] compared what I was going through to "*a double bereavement*": perception of being let down by both, the system and KPMG. I had so totally believed in KPMG; in my eyes, it could do no wrong. I felt betrayed, abandoned, very sickened. The way I expressed the treatment at work was that it had "*shaken me to the bone*".

My access to the internal sites was only resumed on [25 April 2007](#), once I agreed to sign a letter permanently barring me from using the Internet. As my work required some Internet access, I was dependent on colleagues for information, making it a demeaning and humiliating experience.

It is clear that [the ban imposed on me by KPMG](#) was intended to 'make me pay' for 'daring' to stand-up and fight for my rights in relation to my personal problem as (in addition to other related events (\*) ), in [August 2007](#), I was 'allowed' to access the Internet on the condition that I use a spare computer. The ban imposed on me was not computer dependent.

**(\*) (1)** At the time it took action against me, KPMG did not communicate to me other accusations made against me by Mr Ladsky, thereby denying me the opportunity to defend myself against them; **(2)** KPMG subsequently [attempted to deny me access](#) to Mr [Ladsky's communications about me to KPMG](#); **(3)** [It knew that, had I tried, the configuration of the KPMG Internet system would not have allowed me to perform the actions contained in Mr Ladsky's accusations.](#)

(Other events also took place, resulting in my leaving KPMG on [17 January 2008](#))
