Steel Services Limited v Yourself Claim in West London County Court

I refer to your letter of 24th January 2004 and I am sorry that you remain unsatisfied with my response to your earlier letter and to hear that you will shortly be lodging a complaint against my firm with the Office for the Supervision of Solicitors.

We clearly disagree about the advice you were given by this firm and by counsel, although I understand you have also complained about counsel to his professional body.

In respect of the protection of your own rights and your dispute with Steel Services, clearly you must instruct other solicitors as you have no confidence in the services this firm has provided to you.

At this stage, little point would be served in responding to each of the matters that you raised, as these clearly challenge the account that I have given to you from my file which records a sequence of events that happened. Given your threat to potentially commence legal action against my firm it would be entirely improper for my firm to continue to represent you or advise you further. **The last thing I was asking was for this mafia to represent me - see e.g. page My 19 Oct 03 Witness Statement # 1** !!

I am sorry that I was unable to resolve your complaint or the differences between us.
