Since this she has been extremely upset and is seeking compensation and retribution for her time, money and effort.

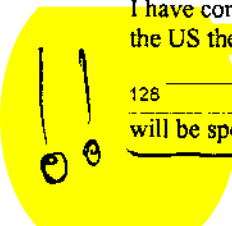

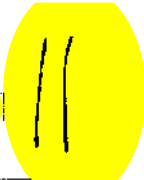
