**Crime report of racially aggravated harassment to Chelsea police...

...residing at 3 Jefferson House, 11 Basil Street, London SW3 1AX ⁽¹⁾
...against the man of Middle-Eastern origin...
...who was driving Citroën car registration number FA52 BEO...
...on 27 July 2010...
...and also followed me on 20 July 2010...
...and, concurrently, against Andrew David Ladsky, Jefferson House; British, DOB 11/08/1960 - who is the instigator of this harassment.**

27 July 2010 - Events

In [My Diary 2010](#)

At 10h52 / 10h53, on Tuesday 27 July 2010, on coming out of the shop, Snappy Snaps, on the Old Brompton Road, in South Kensington, I saw a man, I assessed as being of Middle-Eastern origin, crossing Old Brompton Road, from the opposite pavement, a few metres down, to my left.

(I recognised him from events on 20 July 2010 - see page 3)

He saw that I had spotted him. He made a beeline for a hotel which is 3-4 doors down from Snappy Snaps (attached photograph, entrance at the forefront).

His movements consisted of walking up the two steps, looking inside for one second, whilst remaining under the porch.

He then positioned himself in line with the pillar such that I could not see him from where I was.



I stayed where I was for c. 15 seconds and, as he remained where he was, started to walk in his direction.

He might have seen me do this from the reflection in a shop window across the road, as he then left hurriedly, crossing the road (attached photograph – 10h54)

Hence, he went back the way he had just come from.

I also crossed the road, intending to take a photograph of him.

I continued to follow him, and took another photograph at the beginning of Onslow Place, by the Italian (?) restaurant (attached photograph - 10h56).

He knew, from the reflection in the restaurant window, that I was behind him, leading him to turn his face away from me.

He continued rapidly on Onslow Place and got into a car (attached photograph – 10h56).

As he was coming in my direction, I walked back to the South Kensington main intersection as, due to the traffic, I anticipated being able to take another photograph.

The light turned red when he arrived.

I took the attached 10h58 photograph.

It shows that the car is a Citroën...

...registration **FA52 BEO**

(I then went back to take the photograph of the entrance to the hotel)

20 July 2010 - Events

In [My Diary 2010](#)

This is the SAME MAN who followed me on Tuesday 20 July 2010 i.e. one week previously, on my way back to the flat, from South Kensington.

The attached photograph, at 21h09, is taken in front of the Brompton Oratory. (Of course, he turned away on seeing me point my camera at him).

Fearing for my safety, I remained stationary to see what he would do next.

He hovered near to where I was and, walking past me, continued to do this a few metres away.

As I remained more or less stationary, after c. one minute, he eventually walked off in the direction Knightsbridge.

I believe these actions amount to criminal offences against me under:

- The **Protection from Harassment Act 1997**: [s.1 – Prohibition of harassment](#); [s.2 – Offence of harassment](#); [s.4 – Putting people in fear of violence](#); [s.7 – Interpretation of this group of sections](#) (harassment on at least two occasions).
- The **Criminal Justice and Police Act 2001**: [s.44 – Collective harassment](#) - as I believe the instigator of this man's actions to be [Andrew David Ladsky](#), Jefferson House, (among others, [a fraudster](#), well known to [‘certain individuals’ in Kensington police](#)).
- The **Crime and Disorder Act 1998**: [s.32 - Racially or religiously aggravated harassment](#) – because I am of part German descent and Andrew David Ladsky claims to be Jewish. Among others, this racial hatred was blatantly obvious from Ladsky's so-called [‘complaint’ against me to Kensington police in 2007](#). (And, in the context of this ‘complaint’, the same offence (among others) was also committed against me by TDC Simon J Dowling of Kensington police who quite clearly took on board the information from Ladsky as, in his [16 March 2007](#) and [20 March 2007](#) emails to my website Host (my website: [www.leasehold-outrage.com](#)), he branded me a “Nazi” because of my racial origin).
- The **Public Order Act 1986** – [s.4A – Intentional harassment, alarm or distress](#).
