Given the extreme vagueness of the accusation:

- Your letter of 27 January reports the accusation as follows: "The police have been informed by a Mr Andrew Ladsky that you verbally abused him in public over some sort of dispute revolving around your premises."
- While your correspondence of 4 February states: "... This revolves around an incident on the 25<sup>th</sup> January 2003."

In order for me to respond, please, provide me – **in writing** – with the following:

- Precisely what I am alleged to have said
- Precisely the context in which this is alleged to have been said. You state "over some sort of dispute revolving around your premises". Please, provide specific details.
