We have been instructed by Rootstock Overseas Corp in connection with outstanding arrears of service charges due and which relate to the above premises, details of which you are fully aware of. We have seen copies of the correspondence passing between you and our client's Managing Agents, Martin Russell Jones and would request that all future correspondence be sent to this firm so far as the arrears are concerned.

We enclose a copy of a Statement dated 13th February 2007 which indicates how the sum of £8,937.28 has been calculated. Please note that further sums in respect of electricity will be billed as soon as appropriate accounts have been received from the electricity supplier, and also to be added are the service charge due on 25th December 2006 once the figures have been agreed.

We note that you have failed to make the payments as requested, and as a result of the same, we are instructed to inform you that if payment of £8,937.28 is not received by us on behalf of our client by close of business on Friday 23rd February 2007, proceedings will be issued against you for the full amount due together with interest, without further notice. Such proceedings will not be confined to the service of a Claim Form in the appropriate Court but will also include the issue of a Statutory Demand, which is required under the Insolvency Act 1986 prior to the presentation of a Bankruptcy Petition. Such proceedings will be without prejudice to our client's other rights of recovery and enforcement so far as your property is concerned.

Definition of FORFEITURE

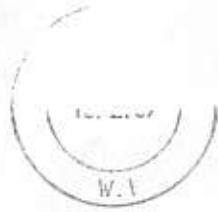

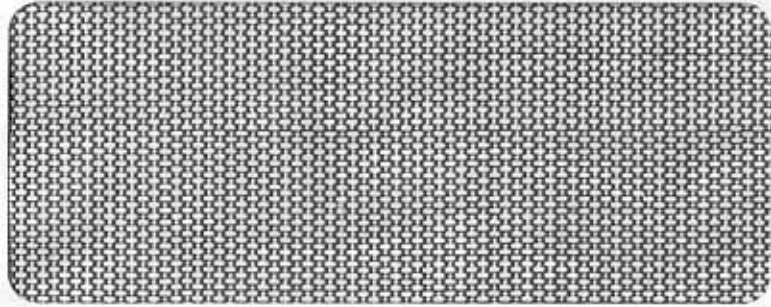
