Dear Madam / Sir

One week to the 24 August 2007 hearing and Portner and Jaskel has not supplied me with its skeleton argument. Yet, it has now been in possession of my skeleton argument for three and half months (since 4 May 2007)

In its order dated 26 April 2007 (attached ¹) your court stipulated: **issued on 19th, but posted on 27th**

"Parties are to file and serve skeleton arguments and any authorities relied upon by 4pm on 03 May 2007"

I complied with the order. The other party did not.

The hearing was cancelled and rescheduled for 24 August 2007.

As, by 30 June 2007, I still had not received the skeleton argument, I sent a letter to Portner and Jaskel, dated 30 June 2007, on which I copied your court, demanding that the documentation be sent to me.

As explained in my 12 August letter to your court, in its 12 July 2007 reply Portner and Jaskel totally ignored my request for this critical information. Its ensuing silence led me to write another letter (sent 'Special delivery'), dated 12 August 2007, reiterating my demand, and specifying that the documents be delivered to me by today's date. (I copied your court on this letter, with my letter of 12 August 2007).

By end of play today, I have not received post from Portner and Jaskel.

The unwillingness to date to provide the requested information - including failure to comply with your court's order of 26 April 2007 - provide overwhelming support to my position that the claim against me is dishonest and vexatious. (Hence, a repeat of Steel Services Ltd claim filed against me in your court in November 2002).

Concurrently, this conduct provides evidence that the claim is a waste of court time, as well as my time. Quite clearly, this breach of the rules of court is intended to gain an unfair advantage and calculated to inhibit your court from furthering the overriding objective.

The oppressive, improper and wholly unreasonable conduct of Portner and Jaskel and its client started in February by threatening me with bankruptcy unless I paid the sum demanded.

Their conduct has caused me to incur unnecessary costs. As previously stated, I intend to demand reimbursement of all my costs since February, as well as compensation for aggravation.
