Yet more deceit by Rootstock Overseas Corp and its advisers

Some time today, the attached two-page (plus cover page) "*Skeleton argument on behalf of the Claimant for hearing on 24 August 2007*" produced by Mr Greg Williams of 2 Gray's Inn Square Chambers, and attached covering letter from Mr Ahmet Jaffer of Portner and Jaskel were delivered by courier to my PO Box address.

I wish to draw your Court's attention to the following in the skeleton argument:

Point 5 states "*The Claimant has not received a copy of the Defendant's skeleton argument in support of her application. The Defendant asserts in correspondence that the Claimant has had her skeleton argument since 4 May*"

I categorically assert that, at the time I sent your Court my skeleton argument on 3 May 2007, I also sent a copy to Portner and Jaskel. As can be seen from the attached copy (page # 7), I did this by '*Special Delivery – Next day*'. (I will bring the original receipt at the 24 August 2007 hearing). (A call to your Court today confirmed that the hearing is due to take place at 10h00).

The following day, I visited the Royal Mail website from which I captured the attached printscreens (# 8). It confirms that the document was delivered to Portner and Jaskel.

In addition to this, I also draw your Court's attention to the following:

- **Rootstock's advisers have waited until 48 hours prior to the hearing to make this claim.**
- In my **30 June 2007** letter to Mr Ahmet Jaffer (I supplied a copy to your Court with my 12 August 2007 letter), I state, in the penultimate third paragraph: "*You have had my skeleton argument since 4 May 2007. I require that you provide me with your skeleton argument within seven days of receipt of this letter...*"
- In his **12 July 2007** reply (copy also supplied to your Court with my 12 August 2007 letter), Mr Jaffer totally ignored this part of my letter. Why? If it were the case that he had not received my skeleton argument, why did not he say so? Reason: because Portner and Jaskel received it on 4 May 2007.

In light of the above, my reply to **Point 8** of the skeleton argument:

"The Claimant has delayed service of its skeleton to the present date in the hope that it may have been able to respond constructively to Defendant's arguments on the application"

is as I stated in my 16 August 2007 letter to your Court: "*...this breach of the rules of court is... calculated to inhibit your Court from furthering the overriding objective*"

Other point in the skeleton argument:

Point 7 – "*Having read the enclosures of 30 June the Claimant is uncertain what argument the Defendant is making in respect of contesting jurisdiction*"

Why has the Claimant waited all this time to state this? What is it unclear about?

Point 6 – "...the Defendant sent to the Claimant... lengthy enclosures which she states are full copies of her evidence sent to the Court on 4 April"

What I sent to Portner and Jaskel with my 30 June 2007 correspondence is an identical - bound copy - of the bound document I sent your Court on 4 April 2007.

At the time, I also asked the printing company to bind my own copy. Using the same printing company I had used to make the 4 April 2007 copy for your Court, on 28 June I gave the company my copy from which it removed the spine in order to make the copy for Portner and Jaskel.
