In my letter dated 28 October, I reminded you that, two weeks previously, with my 7 October 2007 letter, I had sent you a cheque for £150 as deposit for transcribing the above tape (see attached). (The cheque was debited from my bank account on 24 October).

On Tuesday 2 October your Office left a message on my voicemail to say that you had received two tapes from the court.

On Wednesday 31 October, your Office left a message on my mobile voice message service to say that the transcript of the hearing would be with me within 2-3 days. Hence, by the end of last week.

At the date of writing i.e. over one week later, **I still have not received the transcript**. By extension: five weeks on, and I still have not received the transcript.

The 31 October message also stated that the *“judgement part of the hearing had been sent to the court for review by a judge”*.

As can be seen from the attached 24 August 2007 ‘General Form of Judgment or Order’ from West London County Court (posted 2nd class on 5 September 2007), the outcome of the hearing was:

1. Application dismissed (Note: This refers to my 3 May 2007 application for transfer of the case to the Leasehold Valuation Tribunal)
2. Defence & Counterclaim to be filed by 14 September 2007
3. Defendant pay claimant’s costs of today assessed at £293.70 by 7 September 2007

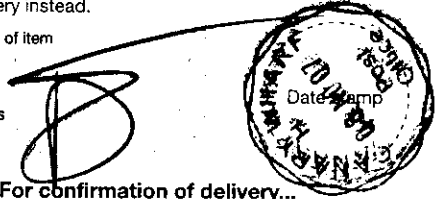
