CONFIRMATION OF COLLUSION¹

Leading me to insist that my case is immediately transferred to a court and a judge committed to operating under CPR's 'Overriding Objective'

So that I can exercise my rights under the European Convention on Human Rights, comprised under the **Human Rights Act 1998**: Article 6 – "Right to fair hearing", and Article 13 - "Right to effective remedy"

Thank you for your letter dated 21 December 2007, in reply to mine of 11 December 2007 addressed to The Rt. Hon. Jack Straw, MP, Justice Secretary (not the "Ministry of Justice" as stated in your letter). (By error, I dated my letter '10' December, instead of '11' December).

You state that you will "prepare a response by 16 January 2008". If this is intended to provide you with the opportunity to see my reply to the Customer Service Officer who reports to Mrs Linda Lennon, Area Director, please see attached my 27 December 2007 response to his 20 December 2007 reply.

The above is the header to my letter to the Customer Service Officer, which summarises my position. As I stated in my 11 December letter to Mr Straw "As a tax paying, (law abiding) British Citizen, I have the right to demand access to the justice system".

Considering West London County Court's conduct to date, as well as in 2002-2004 - also in relation to **another fraudulent** claim filed by at least one of the same parties i.e. Mr Andrew Ladsky - I have the absolute belief that this court would continue to deprive me of my right of access to a "fair hearing" and "effective remedy" – as comprised under the Human Rights Act 1998.

Consequently, I insist that my case is **immediately** transferred to a court and a judge committed to operating under CPR's 'Overriding Objective'. Yes, I do still hold the belief that this requirement can be met – although I will admit that this belief is currently being stretched to the limit.
