
Payment of £293.70 following 24 August 2007 West London County Court Order

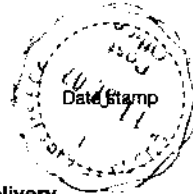

