Dear Madam/ Sir

For the 2nd time (previous, my [10.12.02](#) letter) I was raising the fact that *there was an abuse of process of court*. NOTE that **2 solicitors** acting for my fellow leaseholders said **the same thing**: [solicitor # 1](#); [solicitor # 2](#).

Outcome? **7 weeks later**, in its [24.01.03](#) letter, [HM's West London County Court judiciary](#) communicated that it could not give a damn; it was 'up to me' to police the conduct of [Andrew David Ladsky's corrupt solicitors, CKFT](#).
