We write on behalf of the above named second Defendant. We have her authority to write to you.

Ms. Rawé has reached settlement in this matter with the Claimant and we attach the following copies of the correspondence evidencing the settlement reached:

1. Offer letter dated 21 October 2003
2. Notice of Acceptance dated 19 December 2003
3. Draft consent order dated 19 December 2003
4. Claimant's acceptance letter dated 17 February 2004
5. Defendant's letter requesting Consent Order dated 27 February 2004
6. Defendant's letter requesting Consent Order dated 22 March 2004

All relate to correspondence with Ladsky's racketeer solicitors, CKFT

Due to the lack of response, in Jan 04, I had also asked a solicitor to send a copy of my correspondence to CKFT

You will note that full and final settlement has been agreed between the parties yet the Claimant refuses to sign a Consent Order or indeed respond to any of the second Defendant's attempts to finalise matters in the usual manner.

The second Defendant is not represented and attended at the Court to clarify what had happened procedurally and seek advice on finalising the matter. On 31 March 2004 she was advised by the Court that the Claimant had taken no steps to progress matters and she was further advised that she should complete a Listing Questionnaire.
