1. **Tape**

A hearing of my case took place on 28 May 2004. I did not attend the hearing because of [your Court's fault: you failed to follow instructions by sending the Notice](#) to the Royal Courts of Justice Advice Bureau, instead of sending it to me. It resulted in my being out of the country at the time.

As I want to know exactly what was said at this hearing (which has resulted in [an order with which I totally disagree](#)), on 4 June 2004 I visited your Court and completed a [Tape Transcription form](#) (see enclosed <sup>1</sup>)

I have just spoken to [Beverley F. Nunnery & Co](#), the firm I selected to do the transcript (see enclosed my letter to them dated 24 June 2004 showing copy of the £100.00 cheque I sent them as down payment <sup>2</sup>). They told me that they [have listened to the whole tape](#) they received from your Court on 17 June 2004 – and [could not find a recording of the hearing on the tape](#).

Can you please ensure that the tape that has the recording of the hearing is sent to them immediately.

2. Reply to [my letter dated 20 June 2004](#)

It was a [continuation of the criminal psychological harassment \(Persecution # 1 ; extracts from a Canadian website\) by WLCC's extremely SICK judiciary and staff](#)

At the date of writing I have not received a reply to my letter to your Court, dated 20 June 2004 (see enclosed <sup>3</sup>). This letter was sent by Recorded Delivery on 21 June 2004. The enclosed printout of the [Royal Mail's tracking system](#) states: "[Your item with reference ZU161269315GB was delivered in WEST KENSINGTON before 10:31 on 22/06/04](#)".<sup>4</sup>

Can you please reply to me by return of post.
