You initially confirmed to me that a trial would be taking place on 17 August and you advised me to attend as I was the Defendant in the case. When I asked you for the reason – and pointed out to you (as I have done in my previous correspondence to your Court and to West London County Court) that a Consent Order had been agreed – and signed by both, the Claimant and myself - and that your own Court had in fact sent it to me attaching a 'General Form of Judgment or Order' dated 1st, as well as 2nd July, you said that you would get back to me within 30 minutes.

You did. And in this conversation I read out to you the content of the 'General Form of Judgment or Order' dated 1st, as well as 2nd July sent by your Court. You confirmed that you had this document. The subsequent battle is partly indicated by the RCJ's 02.04.04 letter to West London County Court. Of course, it continued afterwards e.g. my 25.05.04 letter to CKFT, following its 27.04.04 version of the Consent Order

As can be seen from my 26.05.04 letter to CKFT, the version of the Consent Order CKFT had endorsed by Wandsworth County is *exactly the same* (next page)
I sent CKFT my 26 May letter by 'Special Delivery Next Day'. Hence, it received it before the 28 May 04 so called 'hearing' - which Andrew David Ladsky's lapdogs in West London County Court ensured I missed - by deliberately - sending the Notice of hearing to the RCJ (its 21.05.04 letter)
This gave Ladsky's corrupt solicitor, Ayesha Salim, CKFT, the opportunity to spin her story unchallenged (**transcript**) (**WLCC # 13.2**)...
...and in particular achieve the mafia's plan of getting an Order that the action against me be "**STAYED**" (what I had objected to in Salim's 27.04.04 version)...
...from Ladsky's WLCC's lapdog, **District Judge Madge: 'his; 28.05.04 Order - even though he knew that agreement had been reached - as can be seen from pt #4 of the Order, and the transcript**

BY CONSENT it is ORDERED that:-



- The fifth defendant do send to the claimant's solicitors copies of the items requested at (3) and (4) in its List of Documents by 4 p.m. on 11 June 2004.
- There be mutual simultaneous exchange of witness statements by no later than 4 p.m. on 9 July 2004. No witness whose statement has not been so exchanged shall give evidence without the permission of the Court. In the event that either party is unable to serve witness statements within that period, the other party be at liberty to serve witness statements unilaterally and the defaulting party be debarred from calling any evidence at trial. = Benefiting Ladsky who got a freebie from Madge as my not attending...
- As between the claimant and fifth defendant costs in case. allowed Ayesha Salim CKFT, to spin her story unchallenged: transcript - and get this Order..
- Terms having been agreed, the claim against the second defendant be stayed. ...as planned: its 27.04.04 draft I rejected
As there is "agreement"- how can the action be "stayed"???
- The claimant's claim against the fifth defendant be listed for hearing before the Circuit Judge between 1 August and 31 August 2004 with a time estimate of one day, there being no dates to avoid.
