**(I am the Second Defendant – Noëlle Klosterkötter-Dit-Rawé)**

On Monday 19 July 2004, Mr Zaidi, from your Court, phoned me in response to my letter to your Court dated **8 July 2004** (see attached <sup>1</sup>) in which I asked for an explanation of the 'Notice of Transfer of Proceedings' from West London County Court, dated **9 June 2004** (see attached <sup>2</sup>) (with a covering General Form of Judgment or Order – "Before Judge Madge" – dated 8 July 2004 <sup>3</sup>) which states that **my case has been transferred from West London County Court to your Court "for listing for trial before Circuit Judge"**

As you can see from the enclosed fax I sent to Mr Zaidi on Monday 19 July 2004 (at 14h37) <sup>4</sup>, during our conversation, **Mr Zaidi initially confirmed to me that a trial would be taking place on 17 August and advised me to attend as I was the Defendant in the case.**

**When I asked for the reason** – and pointed out to him (as I have done in my previous correspondence to your Court and to West London County Court) that a Consent Order had been agreed – **and signed by both, the Claimant and myself** - and that **your own Court** had in fact sent it to me attaching a 'General Form of Judgment or Order' dated **1<sup>st</sup>**, as well as **2<sup>nd</sup> July** (see attached <sup>5</sup>), he then phoned me back asking me to fax him a copy of the Consent Order as he said to not have a copy and could not find it.

I explained that **I was in a state of terrible anguish and distress** as I did not understand what was going on. **He promised to send me a letter confirming whether or not the 17 August trial concerned me.** At the date of writing - i.e. **4 days later** - I have not received communication of any kind from your Court.

**If the trial does concern me, then I have not been provided with any instructions whatsoever.** As you can see from the attached 'General form of judgment or order' from West London County Court dated **28 May 2004** the instructions under **points 1, 2, 3 and 5 refer to Defendant # 5** <sup>6</sup>.

In addition to pointing this out to your Court in my letter dated **8 July 2004**, I also did this in my attached letter to West London County Court, dated **20 June 2004** <sup>7</sup>. As by 8 July 2004 I had not received a reply, I sent West London County Court another letter, dated **8 July 2004** (see enclosed <sup>8</sup>). **More than one month on** and I still have not received a reply from West London County Court.

I would also like to draw your attention to the fact that **I did not attend the 28 May 2004** West London County Court hearing **due to the Court's fault** – as detailed in my **20 June 2004** letter to them – and in

I provided a copy of the report to the Court, as well as a copy of my surveyor's [31 July 2003](#) assessment of the LVT determination. **My letters to West London County Court** of [22 June 2003](#), [15 July 2003](#) and [9 August 2003](#) provide comprehensive details.

Which, of course, [judge Wright](#) opted to ignore totally – because ["the brother"](#) ([Persecution # 6](#)) [Ladsky](#) 'needed' the money to realise [his multi-million £ jackpot](#)

**I need to know precisely what was said at the 28 May 2004 hearing.** I asked West London County Court to send a copy of the tape to the firm of Beverley F. Nunnery & Co so that they could do a transcript. **The Court sent them the wrong tape. I have had no communication since.**

Having fallen victim to an unscrupulous landlord, I have then been subjected to the most appalling treatment by the Courts which I can only describe as amounting to cruelty and [persecution](#):

- **if this communication that the 17 August trial does not concern me** (and it seems to me that it does not) **it will be the third time that I am told to respond to a Court action that does not concern me**  
e.g. my [29.06.04](#) letter to [Lord Falconer of Thoroton](#)
- **nobody even bothers to reply to my letters making me endure the most awful anguish, distress and torment.**

Please, ensure that I get a reply from your Court by return of post.
